# **Comments from the Mayor and Council**

Mrs. Reese thanked Upstate Gets Snacked for the recent Santa Workshop held at the Depot. She said the event was very successful and was very helpful to families in need at Christmas time.

Mrs. Snipes thanked The Police Department and Sandifer Funeral Home for hosting Santa events for children.

Mayor Ramey stated that the Bigfoot Festival had reported successful numbers and thanked the Committee for keeping the event free and having free activities.

Mayor Ramey also read a letter from Governor McMaster awarding the City of Westminster \$250,000 in Community Development Block Grant funding from the Special Projects Program. He stated these Grant Funds would be used to renovate and expand W. P. Anderson Park. Mayor Ramey thanked Mr. Bronson and Mrs. Snipes for their efforts in helping secure this Grant.

#### 2. Comments from the Interim Utility Director

- a. Mr. Harbin informed Council that the Welcome Sign in front of Walgreens was under contract for repairs and that the Insurance check had been received. He added that it will be completely rebuilt and the contractor is Matt Troyer.
- b. Mr. Harbin informed Council that the C Fund project was nearing completion.
- c. Mr. Harbin informed Council that the drainage issues at the Simpson Street ball field had been addressed and resolved.
- d. Mr. Harbin also informed Council that the final transfer of the 12KV project at the railroad crossing has been scheduled.

# 3. Comments from City Administrator

- a. Mr. Bronson informed Council that a priority-setting workshop has been scheduled for January 12<sup>th</sup> with Jeff Shacker of the Municipal Association from 12;00 – 4:00. Mayor Ramey suggested to Council Members that they be writing a list of priorities to bring to the meeting.
- b. Mr. Bronson informed Council that there would be a Planning Advisory Committee Meeting on January 25<sup>th</sup> at the Depot from 1:00 5:00.
- c. Mr. Bronson reminded Council of the OJRSA Meeting on January 5<sup>th</sup> at 6:00 at the Walhalla Depot.
- d. Mr. Bronson informed Council that he would be scheduling a called meeting at the end of December to award the water line construction bid for the Coopers Mill.

# **New Business**

Consideration of Ordinance No. 2023-01-10-01, Authorizing an Equipment Lease
Purchase Agreement in the amount of not exceeding \$310,000 between The City Of
Westminster, South Carolina, and Truist Bank, A North Carolina Banking
Corporation, to defray the cost of acquiring certain Equipment; and other matters
relating thereto.

Mr. Bronson reminded Council that at the November 15, 2022 City Council Meeting, staff brought forward a request to purchase a new garbage truck utilizing the installment purchase financing mechanism. He added that Staff has since then been able to demo a new garbage truck for several weeks and would like to be able to purchase it when it becomes available in March. Mr. Bronson added that if the City issues a Purchase Order by early-February, the purchase could be secured. He noted that the first payment on the installment financing would be one year from the date the funds are received from the bank and that the timing of the first payment allows the City Council and City staff to provide for funding in the FY2023-2024 Budget.

Mr. Bronson informed Council that the ordinance includes financing for the garbage truck, closing costs and terms of the financing from Truist Bank. He added that the purchase price for the garbage truck is \$294,946.20, financed at 4.01% for 8 years with annual payments between \$33,000-\$44,500. The total financing is for \$310,000, which includes the purchase price of the truck and all closing costs.

2. Consideration of Ordinance No. 2023-01-10-02, Authorizing and Providing for the Issuance of one or more series of Combined Utility System Revenue Bond Anticipation Notes, of The City Of Westminster, South Carolina, in the Aggregate Principal Amount of not exceeding \$8,705,000; Providing for the Form and Details of The Notes; Providing for the Payment of the Principal of and Interest on the Notes; Providing for the Disposition of the Proceeds of the Notes; and Other Matters Relating Thereto.

Mr. Bronson informed Council that the USDA-RD issued a Letter of Conditions (LOC) for a loan of \$8,705,000 for water system improvements to the City. He added that City Council approved a Resolution to accept the loan at its September 13, 2022 Regular Meeting. Mr. Bronson stated that a requirement of USDA-RD loan is to obtain interim financing for the loan amount and that a Bond Anticipation Note (BAN) is the mechanism by which the City may secure the interim financing. The City will use the funds from the BAN to pay for the construction of the water projects and then once construction is completed, the USDA-RD will provide it is financing to close the BAN. From there, the City will begin the 40-year repayment of the loan to USDA-RD.

Upon final approval of this ordinance, referred to as the "BAN Ordinance," staff and the city's bond counsel, Burr & Forman, will solicit financial institutions for BAN funding proposals. The planned schedule is as follows.

3. Consideration of bill payment of \$2,975 (half of the invoice amount) to *Superior Sound and Consulting* for audiovisual services for the 2022 SC Bigfoot Festival at the request of the City's Public Relations Committee

At this time, Council Member Dale Glymph recused himself from the room and vote and the Recusal form is attached to these minutes.

Mr. Bronson informed Council that on November 11, 2022, the Public Relations (PR) Committee submitted an invoice for \$5,950, requesting half the amount or \$2,975 to be paid from the City's PR Committee budget allocation of \$15,000 for the 2022 SC Bigfoot Festival. He added that to date, \$7,939.12 of the \$15,000 allocation has been spent. Mr. Bronson also added that the 2022 SC Bigfoot Festival was awarded a \$9,000 Hospitality Tax grant for the city's current budget year and issued a check for that amount in July 2022. Mr. Bronson asked for Council direction on payment of \$2,975 that is 50% of the total invoice from Superior Sound and Consulting for services provided to the 2022 SC Bigfoot Festival.

Upon a motion by Mr. Dunn and seconded by Mayor Ramey, the motion to approve payment of in the amount of \$2,975 to Superior Sound and Consulting for audiovisual services for the 2022 SC Bigfoot Festival from the budget allocation of the PR Committee passed.

 Consideration of Appointment of Commissioner to Oconee Joint Regional Sewer Authority Board

Mr. Bronson informed Council that the Inter-municipal Agreement and Joint Resolution, effective June 2, 2007, between the cities of Seneca, Walhalla and Westminster creating the OJRSA calls for the appointment of nine (9) Commissioners. He added that Article 4, Section (a) reads, in part, "Walhalla and Westminster shall jointly appoint (1) Commissioner who shall reside outside any of the member-municipalities and who is not an employee of any member." Mr. Bronson stated that Mr. Talley Grant has served as the Walhalla and Westminster jointly appointed Commissioner since March 5, 2012. He served as a Walhalla Commissioner from May 1, 1989 – December 31, 1993. Mr. Bronson informed Council that Mr. Grant has stated his intent to resign from the Board, effective December 31, 2022.

Mayor Ramey asked members of Council to be considering someone for this position.
